Jurisdiction of the Court

Superior Trial Court

The Supreme Court of British Columbia is the province's superior trial court. It is a court of general and inherent jurisdiction which means that it has jurisdiction to hear and decide any matter that comes before it, unless a statute or rule limits that authority or grants exclusive jurisdiction to some other court or tribunal. The Supreme Court's inherent jurisdiction allows it to control its own processes and the procedures before it so as to ensure fairness and to prevent abuses of process. The Court hears both civil and criminal cases as well as appeals from Provincial Court and reviews decisions of administrative tribunals.

Supreme Court Registries and Locations

The Supreme Court is a circuit court in which all the judges and masters travel throughout the province to preside over cases. The Supreme Court conducts proceedings in seven judicial districts and has resident judges in Vancouver, Chilliwack, Cranbrook, Kamloops, Kelowna, Nanaimo, Nelson, New Westminster, Prince George, Prince Rupert, Smithers and Victoria. The Supreme Court also conducts proceedings in the following additional locations where there is no resident judge or master: Campbell River, Courtenay, Dawson Creek, Duncan, Fort St. John, Golden, Penticton, Port Alberni, Powell River, Quesnel, Revelstoke, Rossland, Salmon Arm, Terrace, Vernon and Williams Lake.

Judicial Members of the Supreme Court

The Supreme Court currently consists of the 110 judges: the Chief Justice, the Associate Chief Justice, 88 full-time judges and 20 supernumerary judges.

Judicial Appointments

Judicial appointments are made by the Governor-in-Council on the recommendation of the federal Minister of Justice. The Commissioner for Federal Judicial Affairs oversees the appointment process on behalf of the Minister of Justice. Supreme Court judges are appointed to hold office until the mandatory retirement age of 75 and can only be removed from office for cause. The Canadian Judicial Council, a body comprised of the Chief Justices and Associate Chief Justices of the superior courts in each province and territory and presided over by the Chief Justice of Canada is responsible for investigating and responding to complaints about judicial conduct.

Full-time and Supernumerary Judges

A full-time Supreme Court judge will sit for 32 weeks each year. The balance of the year is spent preparing Reasons for Judgment and other judicial duties. A supernumerary judge will sit 16 weeks each year. Judicial vacancies are created

when a full-time judge retires or when a full-time judge elects to become a supernumerary judge.

Supreme Court Masters

The Supreme Court has 13 masters. Masters are judicial officers appointed by Provincial Order-in-Council on the recommendation of the Attorney General after consultation with the Chief Justice who receives recommendations from an ad hoc committee consisting of the Chief Justice, the Deputy Attorney General, the President of the Law Society of British Columbia and the President of the B.C. Branch of the Canadian Bar Association. Masters preside in civil chambers and registrar hearings and hear and determine a wide variety of applications in chambers.

District Registrars

The Supreme Court also has 3 district registrars who are located in Vancouver and Victoria. They are appointed to the position pursuant to s. 12 of the *Supreme Court Act* and are under the general direction of the Chief Justice. District Registrars hear a wide variety of matters including reviews of lawyers' accounts, bankruptcy discharge applications and bankruptcy taxations, assessments of bills of costs, subpoenas to debtor, passing of accounts, references of various types and settling orders.

Report of the Honourable Chief Justice

I am pleased to have this opportunity to report on the activities and initiatives of the Supreme Court in 2009. I was appointed Chief Justice on September 9, 2009 and since that time I have visited many regions of the province to meet with local bar associations and members of the public. It is important for the Court to provide opportunities for citizens across the province to meet the Court and to tell us about their experiences with the justice system. I have been warmly welcomed in the Kootenays, the Okanagan and Vancouver Island and in 2010 I hope to add a tour through Northern British Columbia.

Public Confidence in the Judicial System

Public confidence in the justice system is an issue of utmost importance for the court. Without public confidence, the authority of the judicial system is diminished. Recently, the Canadian Bar Association released a report prepared by Professor Neil Boyd of Simon Fraser University which looked at the issue of public confidence in the justice system and the factors that affect it. After reviewing the academic literature from the United States, Canada and Europe, Professor Boyd concludes that education is an important factor in maintaining and increasing public confidence in the justice system: the more citizens understand their judicial systems, the more faith and confidence they have in its outcomes. There are a number of organizations that work tirelessly to educate British Columbians about our judicial system including the Justice Education Society, the People's Law School, the Legal Services Society, Access Pro Bono Society of British Columbia and many others. The work of these groups has and will continue to have the full support of the Court.

Judges, Masters and Registrars of the court are also actively engaged in legal education through work with the Law Foundation of British Columbia, the BC Courthouse Library Society, the Continuing Legal Education Society of British Columbia, the University of British Columbia, the Justice Education Society, the Trial Lawyers' Association of British Columbia, the Canadian Bar Association, Camosun College, Justice Institute of British Columbia, British Columbia Institute of Technology, Inns of Court Program and a number of other community organizations that host legal education events for members of the public. I am proud of the volunteer efforts of my colleagues and of the commitment their work demonstrates to the goal of educating British Columbians about our judicial system.

Self-represented Litigants

2009 saw a continuation of the trend of an increasing number of self-represented litigants appearing before the Court. The trend in British Columbia mirrors the trend in other jurisdictions across Canada. There are a number of organizations that continue to provide free or low cost legal advice and legal information to selfrepresented litigants including the Access Pro Bono Society of British Columbia, the Salvation Army Pro Bono Program, the British Columbia Supreme Court Self Help Centre and the Justice Education Society. Given the current economic climate, these organizations are faced with extreme budgetary pressures and an increasing demand for their services.

The Court acknowledges and appreciates the contributions of members of the bar and other community members in providing pro bono assistance to litigants. The Court also acknowledges the various pro bono organizations whose work supports and organizes the volunteer efforts of members of the bar and others. The tradition of pro bono legal services is well established in British Columbia and it is one for which the Court is grateful.

Visiting Judicial Delegations

During the year, the court welcomed judicial delegations from a number of countries including the United Kingdom, Japan and Korea. I and other members of the Court welcome the opportunity to meet with judicial colleagues from around the world. Although our judicial systems vary greatly, there are certain similarities the world over in the art of judging. We learn much from our visitors about their judicial systems and traditions and this knowledge enriches our understanding and appreciation for the judicial system that we enjoy in Canada.

The Work of the Court

Appendix A gives a statistical picture of the Court's workload over the past year. In general, the Court maintains the ability to offer early trial dates across the province:

- Civil and family trials estimated at five days or less can be scheduled within five to six months.
- An in-custody accused can expect a trial date within four months.
- An out-of-custody accused can expect a trial date within six to eight months.

I think it is important for litigants to be confident that the court is willing and able to schedule their matters and that trial dates for most matters can be obtained without significant delays on the part of the court.

The BC Snapshot

In 2009 there was a decrease from 2008 in the number of trials and long chambers hearings that were bumped. This is due, in some part, to the significant number of judicial appointments that were made to the court. The Court greatly appreciates the commitment that the federal government has made to ensuring that judicial vacancies are filled in a timely manner.

In 2009, there were:

• 52,327 civil filings (an increase of 9% from last year; see Figure 1);

- 13,088 family filings (a decrease of 5% from last year; see Figure 1); and
- 1,054 criminal filings (a decrease of 30% from last year; see Figure 1).

The Court heard 1246 trials throughout the province which represents no significant change from 2008. In 2009, 43 trials were bumped; again, virtually unchanged from the 2008 figure. (See Figure 4).

The Court also heard 1782 long chambers applications which is a slight increase from 2008. In 2009, 59 scheduled long chambers applications were bumped which is a slight decrease from 2008 (see Figure 6). More expansive information as to trials heard and bumped by location is set out in Figures 8, 9, and 10.

Scheduling Information

As part of the Court's commitment to provide the public with accurate and timely information, scheduling information has been available on the court's website since 2006. Members of the public can obtain scheduling information for family, civil, and criminal hearings for all Supreme Court registries in the province.

In 2009, the Court began providing information for scheduling Judicial Case Conferences, Civil Pre-Trial Conferences, Registrar Hearings, Rule 68 Case Management Conferences and Summary Conviction Appeals. The publication of this information has significantly improved the efficiency of scheduling dates for a variety of proceedings as counsel needing to schedule a hearing will consult the website for the available dates, work out a date with opposing counsel and then contact Supreme Court Scheduling to book the hearing.

Supreme Court Rules

After a lengthy period of drafting and consultation, the new Civil and Family Rules were adopted on July 1, 2009. They will come into effect on July 1, 2010. The 12 month period between the approval of the new rules and their implementation has provided the Court, members of the bar and the public an opportunity to become well acquainted with the new Civil and Family Rules.

Redesigned Website

The court launched a newly designed website in 2009. The most significant element of the redesign was a complete overhaul of the search engine for the Reasons for Judgment. The judgment database is the heart of our website. The work that we did leading up to the redesign told us that the vast majority of our website visitors look at the Reasons for Judgment. The new search engine improves the ability to search for cases in our judgment database. The feedback that has been received to date has been uniformly positive. The website also provides improved access to scheduling information, registry and Scheduling Department contact information and resources for self-represented litigants. In 2010, we anticipate providing additional enhancements including an RSS feed for Reasons for Judgment and Announcements and a site search.

Acknowledgements

The Court is served by a staff of professional and experienced personnel in the registry and in the courtrooms and by our judicial administrative staff and judicial law clerks. I extend my thanks to all members of the staff for their efforts on behalf of the Court. I also wish to express my appreciation to my colleagues – the judges, masters and registrars of this Court for their hard work and dedication to the administration of justice in BC. In the few short months that I have been in this office, they have warmly welcomed me and I look forward to continuing to work with them.

Changes in the Court's Complement

2009 was an unusually busy year for new appointments and retirements for the Supreme Court. The Court saw the retirement of one Chief Justice and the appointment of a new Chief Justice. We also welcomed the appointment of many new members to the Supreme Court, congratulated two of our colleagues on their appointment to the Court of Appeal and saw the retirement of a number of our senior colleagues. Sadly, we also mourned the untimely passing of one of our colleagues.

The Honourable Mr Justice John S. Harvey was appointed to the Supreme Court at New Westminster on January 23, 2009. Mr Justice Harvey was appointed to fill the vacancy created when the Honourable Madam Justice Daphne Smith was appointed to the Court of Appeal.

Mr Justice Harvey received a Bachelor of Laws from the University of British Columbia in 1977 and was called to the Bar of British Columbia in 1978. Mr Justice Harvey practised in the area of family law and in 2008 was appointed Queen's Counsel. At the time of his appointment to the bench, Mr Justice Harvey was a partner at Scarborough, Herman and Harvey.

The Committee welcomed two new members to the Committee in 2009: Mr. Justice Myers and Madam Justice Griffin.

In 2009, the Committee continued its work in respect of the amendments to the *Rules of Court*, model Anton Pillar orders and Mareva injunctions, improvements to the processing of sealing orders and a review of the publication ban issues. The Committee also began studying the process of how court orders are entered and what changes could be made to improve the efficiency of the process and to ensure that orders are entered in a timely fashion.

Looking forward to 2010, the Committee will continue to participate in the education of the Court with respect to the New Civil and Family *Rules of Court*. Members of the Committee will also continue to produce and distribute Civil Case Alerts which summarize recent decisions of the B.C. Court of Appeal and the Supreme Court of Canada which are of significance in the area of civil law.

Courthouse Facilities Committee

The Courthouse Facilities Committee was constituted in 2006 as a standing committee of the Court. The composition of the Committee is intended to reflect regional representation.

In 2009, much of the Committee's time was devoted to evaluating and making recommendations to the Chief Justice on the Court's response to proposals from the Court Services Branch of the Ministry of the Attorney General respecting Courthouse security. Specifically, the proposals that were put forward included a new high security Courtroom in the Courthouses in each of Victoria and Prince George, security cameras in more Courtrooms throughout the Province where criminal trials are most often conducted and airport style perimeter security for the following Courthouses: Vancouver Law Courts, Victoria, New Westminster, Prince George, Kelowna and Kamloops.

During the year, the Committee also continued its work with respect to facilities for juries both in and out of the Courtroom. In an effort to obtain additional information about concerns with the current jury facilities around the Province, a questionnaire to be completed by judges conducting trials in locations where the Court does not have a resident Judge was prepared.

The Criminal Law Committee had some changes to its membership and leadership. After nearly 6½ as Chair, Madam Justice Holmes decided to hand over the reins to Mr. Justice Cullen. Madam Justice Holmes has been and will continue to be a valued member of the Committee. In addition, Madam Justice Bennett resigned from the Committee upon her elevation to the Court of Appeal. Madam Justice Bennett was a long serving, dedicated and hard working member of the Committee for many years especially in respect of her contributions to the education of her colleagues on issues related to criminal law. In October 2009, Mr. Justice Smart agreed to assume the duties of Vice-Chair. Finally, the Committee welcomed some new members: Mr. Justice Leask, Madam Justice Dickson and Madam Justice Ker.

In 2009, the Criminal Law Sub-Committee completed and presented its final report on the management of criminal proceedings. The Sub-Committee recommended some changes to the management of criminal proceedings in British Columbia which were approved by the court in May 2009. The Sub-Committee then embarked on a period of public consultation which culminated in the development of the *Criminal Pre-Trial Conference Management Pilot Project* which will take effect on March 1, 2010 and which will operate for one 1 year.

In addition to its work with the Criminal Law Sub-Committee, the Committee also provided the Court with assistance as to various matters that arose during 2009, including:

 Review of the Court of Appeal decision in *R v. Mizen* which addressed the need for clarity, precision and transparency in the sentencing process and the need to provide a complete and proper record of an offender's punishment. As a result of its review of this decision, the Committee recommended to the

Chief Justice that he issue a direction that all oral reasons for sentence be transcribed. The Chief Justice accepted the Committee's recommendation and, effective, February 1, 2010, all oral Reasons for Sentence will be transcribed.

- Considered and commented on a new process for fixing dates in criminal proceedings in Vancouver and New Westminster which will be introduced in February 2010
- Provided feedback on proposed modifications to Courtroom 62 to accommodate larger criminal jury trials
- Provided regular updates to the Court on current issues in criminal law
- Participated on the Vancouver Law Courts Users Group which is a group made up of criminal registry and court clerk staff as well a members of the bar who meet to discuss registry concerns with respect to procedures in the registry.
- Participated on other internal court committees including the Publication Ban Working Group and the DARS Access Policy Review Group.
- Assisted the Court's Education Committee by facilitating and providing speakers for criminal law programs at the Court's education conferences including *Extradition Act* and *Mutual Legal Assistance Treaty* proceedings, bail procedures and evidentiary issues.
- Supported and its members participated in the court's Law at Lunch program.

The mandate of the Education Committee is to assist members of the court to stay informed about developments in the law and to organize regular educational conferences addressing topics of interest.

There were a number of changes to the membership of the Committee in 2009. Mr. Justice Davies resigned his position as Chair; however, continues to serve as a member of the Committee. Mr. Justice Kelleher who served as one of the Committee's Vice-Chairs took over the duties as Chair after the May 2009 Conference. The Committee welcomed a number of new members: Madam Justice L. Smith, Madam Justice Ballance, Mr. Justice Bernard, Madam Justice Fisher and Mr. Justice Butler. The Committee also accepted the resignations of Mr. Justice Goepel and Mr. Justice Slade. In addition, Madam Justice Garson left the Committee upon her appointment to the Court of Appeal. The Committee is very grateful for the valuable contributions made to the its work and to the success of the its educational programs by Mr. Justice Goepel, Mr. Justice Slade and Madam Justice Garson.

In 2009, two very successful educational conferences were held. The May conference was held in Kelowna while the November conference was held in Vancouver. In addition to the two conferences, the Committee organized a number of informal education sessions which took place bi-monthly during the noon recess. Judges outside Vancouver attend these sessions via teleconference.

The National Judicial Institute continues to provide tremendous support to the Education Committee by way of organizational, planning and logistical assistance for the court's educational conferences. The Committee is most appreciative of this support.

In 2009, the Committee continued to provide members of the Court with memoranda on topical issues in family law and commentaries on significant family law cases. After developing the protocol to implement the Hague Convention which addresses inter-jurisdictional child custody disputes, the Committee continued to monitor and review the use of the Protocol to ensure that these applications are addressed as quickly as possible. The Committee continues to meet to discuss issues of family law that arise. Looking forward to 2010, the Committee anticipates that the coming into force of the new Family Rules will be the focus of the Committee's attention.

The Law Clerk Committee oversees the Judicial Law Clerk Program which was created in 1973 with the goal of improving the quality of advocacy in British Columbia. Each year the Court hires law school graduates who have not yet been called to serve as law clerks to the judges of the Supreme Court.

In September 2009, eighteen law clerks began their clerkships. For the first year in the program, three law clerks were assigned to New Westminster, thirteen law clerks were assigned to Vancouver and two clerks were assigned to Victoria. The Supreme Court law clerks for the 2009/2010 term are:

Each law clerk is assigned to a complement of five to seven judges for whom they undertake legal research and editing and proofreading Reasons for Judgment.

The Committee wishes to extend its gratitude and appreciation for the assistance that they provide to the judges and masters of the Court. The enthusiasm, commitment and dedication that they bring to the work that they do for the Court is invaluable and the members of the Court benefit greatly from the presence of the law clerks.

In 2009, the Committee oversaw the replacement of the court's computers, introduction of a new operating system and a complete overhaul of the court's judgment template. The Computer Replacement Project went smoothly due in no small measure to the planning and training that the judicial support and IT staff put in place prior to the replacement. The Committee was also involved in overseeing the launch of the Court's new website in January 2009. The feedback received by the Committee is that the work done to improve the judgment search engine has been well received and much appreciated. In addition, the Committee began to work on developing policies to assess the acquisition of new software applications and hardware for the members of the Court.

Looking forward to 2010, the Committee will continue working on developing policy that will assist judicial staff carry out their roles. The Committee is also overseeing some pilot projects including expanded use of the Judicial Module for the electronic approval of court orders and the use of tablet laptops by the judiciary as well as the development of a site search function for the Court's website and the re-launch of the Court's intranet site.

Judges Library Committee

As always, the Judges' Library balanced the need for up-to-date library resources with budgetary constraints.

Expenditures for 2009 totalled \$268,677.79, the majority of which (\$241,557.62) was spent on the top three legal publishers for loose-leaf services, law reports and journals. Total expenditures have declined by \$26,744.34 since 2008.

Subscription services have been trimmed. The full subscription to the D.L.R.s in Victoria was replaced by the paper parts from the Vancouver subscription that are bound and sent to Victoria. This leaves one current set in Vancouver rather than two.

The Judges' Libraries in Victoria, New Westminster, Kamloops and Kelowna are maintained either by local court staff or periodic visits from library staff from Vancouver.

An on-going task is the processing and maintenance of the Court of Appeal and Supreme Court judgments. Library staff processed 573 Court of Appeal judgments, 1915 Supreme Court judgments and 11 Yukon Court of Appeal judgments.

The Judges' Library asked by e-mail whether there was a need for a current copy of the BC Lawyers directory which costs over \$11,000 for 233 copies. The response resulted in a reduction of 57 copies. Free on-line services are available on the Intranet.

Lastly, the Judges' Library gratefully receives donated materials from judges and law offices. Wherever possible, the library endeavours to re-use and recycle material such as criminal codes to public libraries and the Justice Education Society.

Mandate of the Committee

The *Court Rules Act*, R.S.B.C. 1996, c. 80 provides that the Lieutenant Governor in Council has the power to make rules governing the conduct of litigation in the Supreme Court. The Rules Revision Committee ("Committee") has an advisory role, assisting the Attorney General in making recommendations to the Lieutenant Governor in Council for rule changes. The Attorney General appoints the members of the Committee by ministerial order, after consultation with the Chief Justice and the Chair. The Committee includes judges, masters, legislative counsel and members of the bar. The members of the bar are chosen for their expertise in civil or family litigation and also broadly represent larger and smaller centres of the province.

After the Committee makes recommendations to the Attorney General regarding proposed amendments, the Attorney General consults with the Chief Justice as is required by the *Court Rules Act*, before presenting the amendments to Cabinet. With the exception of some stand-alone amendments, proposed rule amendments are typically presented to Cabinet in a package each spring. Upon Cabinet approval, the amendments are enacted by Order-in-Council and are usually effective July 1st. Copies of the Orders-in-Council giving effect to the amendments as well as the full text of the Rules is available on the Court's website at <u>www.courts.gov.bc.ca</u>.

The rewriting of the Supreme Court Civil and Family Rules has involved a significant departure from the usual, incremental process by which rules amendment takes place. Successive drafts of the proposed new rules were issued for comment and extensive consultation with the judiciary, the profession, litigants, and members of public

occurred with the final consultation period being extended to December 31, 2008. The Committee is most appreciative of the thoughtful input that was received.

The Chair wishes to take this opportunity to thank the members of the private bar on the Committee who have so generously volunteered their time and assistance to the work of the Committee.

Composition of the Committee

The Committee's composition changed in 2009 with the resignations of Master Baker who had served for a number of years on the Committee, and of Madam Justice Garson who resigned on her appointment to the Court of Appeal.

New Supreme Court Rules

Historically, rule amendment has proceeded incrementally, with proposals for rule change typically originating with the Committee, or suggested by the judiciary or the profession. In 2006 the Civil Justice Reform Working Group (CJRWG)¹ released its report, "Effective and Affordable Justice" (the "Report") which called for the Supreme Court Rules to be rewritten. A civil drafting group and a family drafting group were established with the mandate, respectively, to create a set of draft civil and family rules reflecting the recommendations of the Report. The drafting groups were established because it was thought that the task of wholly rewriting the Supreme Court Rules was too large for the Committee to take on.

Successive drafts of the new Civil and Family Rules were issued for consultation with the consultation period ultimately extending to December 31, 2008.

The Committee reviewed all of the input received over the course of the consultation period and made its final recommendations to the Attorney General in the spring of 2009. The new Civil and Family Rules were deposited as B.C. Reg. 168/09 and 169/09, and will come into effect on July 1, 2010.

The deferred effective date permits time for the bar and the Court to become well acquainted with the new Civil and Family Rules. As well, the Committee has an opportunity over the course of the next year to recommend further amendments to the Rules before their effective date, as necessary.

The Committee welcomes comments from the Court, members of the bar and the public related to its work. We also appreciate receiving copies of judgments that identify any ambiguities or anomalies in the Rules.

Mandate of the Committee

The Committee is a joint committee consisting of representatives from all three courts and Court Services members. The Committee develops draft policies and interacts with the various court committees, seeking guidance and approval for the draft policies relating to access to court records, specifically in electronic format. The Chief Justices and Chief Judge are consulted before a policy is adopted. In addition to policy work, the Committee also reviews access applications for those seeking bulk access to court record information.

Work of the Committee

In 2009, work of this Committee continued to revolve around issues relating to the Digital Audio Recording System (DARS), discussions about access to criminal record information, and consolidation of the various access policies. There were also decisions made regarding access to documents through Court Services Online. The judiciary is involved in preparing a publication ban manual for both judges and staff.

The Public Access Policy for all three courts has been sent to court committees for discussion and approval.

Access to criminal information continues to be discussed. The Provincial Court criminal information was made available to the public online in November 2008 and free access continued through 2009. During 2008-2009 the number of searches was in excess of 40,500. In 2009-2010, the searches increased to 60,800. There will be a dramatic decrease in 2010 once the search fee is introduced. The issue for 2010 will be to determine the criteria for those seeking fee exemptions to access the database.

Technical work is proceeding to permit counsel to access files online which are not available to the public (such as family files).

During the year, the Committee received, considered, and granted a number of applications from a variety of government agencies and departments for access to court records for the purpose of fulfilling their statutory mandates.

Looking Forward to 2010

In addition to considering applications for access to court records, the Committee expects to complete its work on the Public Access Policy and the DARS Access Policy. The Committee will also continue to work on finalizing an Access Policy Manual which is designed to assist Court Services staff in accessing and understanding the access policies of the courts.









Figure 5 shows the number of civil (including family) and criminal trials heard and bumped in Vancouver from 2000 to 2009.






Figure 7 shows the number of civil (including family) long chambers applications heard and bumped in Vancouver from 2000 to 2009.
